DP World Australia (DPWA) Brisbane – Final Confirmation Notice

**Landside Charges (excluding Terminal Access Charges) effective 01 January 2024**

**Terminal Access Charges – Export & Import effective 01 February 2024**

In accordance with the National Voluntary Guidelines (NVG), DPWA had issued a notification to industry on 31 October 2023 and sought feedback to the proposed rates.

Feedback has been around the quantum of increase on Terminal Access Charges (East coast) and DPWA response is summarised in the Issues Log below.

Final DPWA Brisbane Carrier Access Public Tariff Schedule is included in the table below.

## Issue Log:

### 1. Quantum of increase on the Export Access charges (East Coast):

In accordance with the National Voluntary Guidelines, we are only able to review our landside charges once a year.

DPWA Export Access charges have been trailing at a significant discount to Import Access charges considering the level of capital investment is for the users of the terminal and benefits the Importers and Exporters alike. We offered a level of discounting to assist the Export market for a period and working towards fully closing the gap in the coming years.

Based on the concerns around the quantum of increase and conditioning required for the market on this change, DPWA is delaying the Effective Date on Access charges – Imports & Exports to **1 February 2024**. This should provide some assistance in planning and management. All other Landside / Ancillary charges will be effective **1 January 2024**.

In addition to the above, DPWA can confirm the earliest period it may look to **fully close** the gap between Export and Import is no earlier than start of 2026. Export Access Charge can expect to trail Import Access Charge for at least another 12 months beyond 2024.

[1] If a reefer container is held at the terminal beyond the free storage period, reefer service charges will apply in addition to the daily storage charges. These charges are applicable per day after the free storage period.

[3] Hazardous Containers will incur an additional charge per day, as above, in addition to the daily container storage charge after the expiry of the Free Storage Period.
